The Codebook for the ROCKWOOL–Duke Comparative Indigenous Child Welfare Database is a product of National Data Archive on Child Abuse and Neglect (NDACAN). NDACAN is funded by the Children's Bureau, Administration on Children, Youth and Families, Administration for Children and Families, Department of Health and Human Services. NDACAN supports secondary analysis of its datasets by providing technical support.

This code book includes information on the NDACAN archived version of the Comparative Indigenous data files to assist individuals in using the data.

User's should refer to the User's Guide for important considerations to understand when using the data.

Codebook Entry Guide

Codebook Entries correspond to each variable and contain the following information:

- Number: Unique numeric value corresponding to the variable
- Name: Unique descriptive name corresponding to variable
- Label: Brief description of the variable
- Description: Extended description of the variable
- Data Type: Description of the variable format (i.e. numeric or character)
- Details/Guidance: Detailed information about the variable, such as the categorical levels, information about measurement, data collection, or variable meaning or cautionary notes about data limitations.

Additional considerations

Not all variables are relevant for each country. In other words, not all countries have values in all variables. For example, the variable "boarding" only has values in Denmark where that variable is relevant. Variables "placement_type" and "placement_type_grps" only have values for Greenland where those variables are relevant. Refer to the User's Guide for additional information.

Data for Denmark and Greenland are reported by calendar year (Jan 1-Dec 31). Data for United States are reported by federal fiscal year (FY) (Sept 1-Aug 30), for example, FY 2020 goes from Sept 1, 2019-Aug 30, 2020. The reference date for the point-in-time measures of Greenland is January 1st of the given year; and Sept 30 for the point-in-time out-of-home measure in the United States.

Denmark and Greenland identify indigeneity by parental Greenlandic descent, therefore individuals from Greenland are all considered Indigenous here. The United States Indigenous population include those who identify as Native American or Native Alaskans, who are non-Hispanic and don't identify as any other

race (i.e. not multiracial).

Details/Guidance: Greenland provided additional granularity in the details of their out-of-home

counts, providing the type of out-of-home setting in which a child is placed.

This variable has missing values for Denmark and United States.
