STUDY OVERVIEW

Purpose of Study

To identify factors that significantly increase or decrease the likelihood that a child maltreatment report will be substantiated once an investigation has occurred.

Sampling and Data Collection Procedures

The 1,874 child maltreatment reports examined in this study are a representative sample of abuse and neglect reports received by the New York State Child Abuse and Maltreatment Register between April 1, 1985, and August 31, 1985. In New York State, all reports of child maltreatment are required by law to be immediately made known to this state central registry (SCR) which in turn forwards the reports to county child protective agencies for investigation. In 1985, NYS received a total of 84,119 child maltreatment reports. Because state data revealed that only about 11% of all reports were classified as abuse rather than neglect, the investigators decided to oversample abuse reports so that a relatively equal number of abuse and neglect reports would be chosen for analysis. A specific concern of the study was to investigate the size and nature of the difference in substantiation rates for reports originating from professional sources mandated by law to report suspected cases of child maltreatment compared to reports from non-professional sources, such as relatives and neighbors.

In order to select cases for the sample, case numbers were identified through management reports documenting case activity. All reports for this time period were screened and classified as involving either abuse or neglect. Every other abuse report was selected for the study, whereas every 20th neglect report was chosen. This procedure resulted in two representative samples, one for abuse and one for neglect. The abuse reports were further broken down into reports involving sexual abuse or physical abuse. (A report involving both sexual abuse and physical abuse was classified as sexual abuse). The final sample consisted of 198 physical abuse reports, 796 sexual abuse reports, and 880 neglect reports.

Measures

The measures employed in this study were drawn from three written reports used in New York State by caseworkers investigating child maltreatment: (1) an initial report; (2) a 7-day progress report; and (3) a 90-day case determination report that documents the results of the investigation in terms of whether the allegations were substantiated or unsubstantiated. Once a case was selected, all information from these written reports that is normally collected was coded by trained SCR staff.

DESCRIPTION OF MACHINE-READABLE FILES AND AVAILABLE SUPPLEMENTARY DOCUMENTATION

The Substantiation of Child Abuse and Neglect Reports (SCANR) datasets includes three machine readable files. The first file "CHABUSE" contains information on all the children coded in the abuse category, the second file "CHMAL" contains information on all the children classified in the neglect category and the third file "SCANR1" is a case level file which retains information on all children in the report and combines cases of abuse and neglect. The two child files, one for the abuse sample (CHABUSE) and one for the neglect sample (CHMAL), are files in which one child from the family was randomly selected as the unit of analysis. This procedure controls for the clustering of case characteristics within reports involving several children (e.g., ethnicity of the children) while still maintaining a representative sample of all maltreated children. The investigators recommend using these child files for conducting most types of data analyses. A separate codebook was developed for the child files which is included in this documentation along with the original codebook for the SCANR1 file.

The electronic files are available in a variety of ready to use file formats. Each data order comes complete with documentation and installation instructions. Please refer to the order form for more information.

File 1: CHABUSE

This dataset contains all the abuse cases (including sexual and physical abuse). There are 1,023 observations and 236 variables.

File 2: CHMAL

This dataset contains all the neglect cases. There are 905 observations and 236 variables.

File 3: SCANR1

This dataset retains information on all children involved in the case. There are 1,928 observations and 326 variables.

Notes Regarding Data File

The coding process was designed to obtain a set of case-specific data that faithfully reconstructed the information contained in the written reporting forms. The coding scheme enabled the linking of specific perpetrators with specific children for specific allegations, and the associated determinations. Since any report can have multiple children, multiple perpetrators, and multiple allegations, "line numbers" on the reports, which assigned a number to each person involved in the report, were used to enable the linking of specific people and allegations.

The outcome variable for this study is a dichotomous variable reflecting the result of the investigation coded as either unsubstantiated (0) or substantiated (1). In practice, a case is considered substantiated if credible evidence is found for any of the allegations reported.

Coding conventions:

1) a code of "99" or "9" was used when information pertaining to that item was MISSING or UNKNOWN in the forms or the coder could not ascertain what was recorded (e.g., an illegible entry).

2) INAPPLICABLE or INAP refers to a situation in which a code for that item is impossible given the circumstance of the report. For example, the report that only involves 1 child, items referring to child 2,3,4 etc. would be INAP. Items which are INAP are always left blank.

Classification of Reports:

In New York State, the classification of the report as abuse or neglect is not directly tied to the allegation except for reports involving severe physical injuries or sexual abuse or cases which involve one allegation only. Most cases involve multiple allegations and these allegations do not get classified so directly. Although certain types of allegations are frequently classified as abuse cases (e.g., fractures, burns) other allegations are less predictable. For example, in this study the allegation of excessive corporal punishment is sometimes classified as abuse while at other times it is classified as neglect. The person who initially accepts the report assigns a "role" code to each child listed in the report. The role code designates whether the child was involved with abuse allegations or neglect allegations, or whether the child had no or unknown involvement with allegations. The assignment of the role code takes into account the types of allegations in addition to other factors such as the age of the child, and the severity and number of allegations in the report. Abuse allegations take precedence over neglect in the classification of the case, so that a case involving both abuse and neglect allegations is classified as abuse.

DERIVED VARIABLES

A number of variables were created and are included in all three data files (CHABUSE, CHMAL, and SCANR1). The following table specifies the name of the variable, the variable(s) from which it was derived, and its value.

- (4) Recodes CHSEX: 1= MALE; 0=FEMALE; Recodes missing value to "."
- (5) Recodes CHETHN: A value of "9" is recoded as missing (".") and values of 4, 5, 6, or 7 are recoded as "4" (which signifies the category "Other").
- (6) Recodes missing values
- (7) Recodes PHONE to "XPHONE" 1=has a phone; 2= has no phone
