# Codebook Notes

## Introduction

The Codebook for the Voluntary Cooperative Information System (VCIS) is a product of National Data Archive on Child Abuse and Neglect (NDACAN). NDACAN is funded by the Children's Bureau, Administration on Children, Youth and Families, Administration for Children and Families, Department of Health and Human Services. NDACAN supports secondary analysis of its datasets by providing technical support.

This code book includes information on the NDACAN version of the VCIS data files to assist individuals in using VCIS data. The NDACAN data files differ from other versions of VCIS data that may be extant. See the User's Guide for details on NDACAN processing of VCIS data.

## Terminology

**Variable:** A Variable is a logical set of attributes (e.g. State FIPS Code or Number of Children in Care, White non-Hispanic) having specific values in each state-year (e.g. Minnesota 1989).

**Source:** A Source is a question on the VCIS data-gathering instrument, the response to which provides the information in a Variable. A Variable has a derived Source if it does not correspond directly to a question in the data-gathering instrument.

**Variable Group:** A Variable Group organizes Variables according to Sources, i.e. questions on the VCIS survey instrument. For example, all Variables in Variable Group 8: Children Entering Care, by Age have the same Source, Question 2b. Variable Groups generally include (i) a set of Variables corresponding to mutually exclusive and exhaustive responses to a survey instrument question, and (ii) a Variable representing the total of all these responses.

## Codebook Entry Guide

Codebook Entries correspond to Variable Groups. Each Entry contains the following information:

- Variable Group Number: Unique numeric value corresponding to Variable Group
- Variable Group Name: Unique descriptive name corresponding to Variable Group
- Variables Table: Table of Variables belonging to Variable Group
  - Variable Number: Unique numeric value corresponding to Variable
  - Variable Name: Unique descriptive name corresponding to Variable; used for identification of Variables (columns) in Data Files.
  - Variable Label: Unique full description of Variable.
- Details: Detailed information about Variables in the Variable Group, such as additional explanation of Variable meanings or cautionary notes about data limitations
- Source: Question in the data-gathering instrument generating information in the Variable Group



- Values Table: Table of possible Values that Variables in the Variable Group can take
  - Value: Possible value of Variable, i.e. contents of cells in Data File
  - Value Label: Full description of Value
